**INSTRUCTIONS TO CONTRIBUTORS:** Manuscripts are accepted as E-mail attachments in Word format to [burcham\\_jan@columbusstate.edu](mailto:burcham_jan@columbusstate.edu). To facilitate the blind review process, the author(s) should only include identifying information on the cover page and a running head on the remaining pages. All manuscripts must be in the latest APA format using 12 point, Times New Roman font in order to be considered for publication. The *Publication Manual* (6<sup>th</sup> ed.) of the American Psychological Association provides guidelines for manuscripts.

Manuscripts will be acknowledged upon receipt. The review process takes approximately six to eight weeks. The author or principal author will be notified of the editorial decision. Manuscripts in the following categories are considered: original research studies, book reviews of books not more than two years old, and essays. General guidelines request that research studies be between 8 and 15 pages in length, and book reviews and essays be between 1 and 8 pages in length. Authors should identify the category for each submission.

In reviewing manuscripts, reviewers consider the general importance and interest of the manuscript to the journal's readers, originality, scientific soundness, and the degree to which conclusions are supported by data. Presentation, length, methods, data presentation, and statistical design are also considered. Manuscripts should be well written and free of errors.
